



Approval of Meeting Minutes	Motion to approve: Commissioner Robert Cole (M) Commissioner Dylan Boldt (S) Motion Passed		
Public Comment	Cara Williams, SEIU Chapter President for Veterans Service Representatives and clerical staff, attended as an SEIU representative and veteran (former Navy) commented on the following: o Reported that SEIU meets regularly with Social Services management regarding department changes and expectation o Expressed concern about the relocation of the Veterans Service from Eastmont to Hayward and noted uncertainty over who made the decision. o Stated that removing services from Eastmont would be a disservice to veterans, as the Hayward site is not easily accessible. o Due to the bureaucracy of public service and classification processes, there is currently a staffing shortage. It was noted		

	that training for Specialist Clerks who support veteran services involves many nuances related to certification requirements. Her primary reason for attending was to address the availability and locations of services for veterans.		
	There was further discussion regarding the new stand-alone office with Cara Williams and commission members.		
County Updates:	Sonya Frost, Division Director gave updates to the following: Staff Update: Staffing remains stable. One Veteran Service Representative (VSR) returned briefly for one or two days but has since gone back out. We currently have five Veteran Service Representatives working, and there is one vacancy within the CVSO). Stand-Alone Update: There is no confirmed move-in date yet; we're aiming for the end of the year or early next year. The military and American flags have been delivered and will be installed soon. Orders for Wi-Fi and the security system are in progress. Furniture has been finalized, and we're working on securing the contract with the security company. On Monday, October 27, the Veterans Service Office, represented by Anthony Simpson, Veterans Service Officer, will present at the Alameda County Board of Supervisors meeting at 2:30 p.m. Anthony, along with one of the Veteran Service Representatives, is attending the CVSO Fall Conference this week. Jennifer is on vacation, which is why they are not present.		
	Diarra Piggue, who was recently promoted to an Out-of-Class position as Administrative Specialist I, has left; currently, there is no administrative staff aside from Jonathan. Jennifer will hold interviews as soon as HR can schedule them. In the meantime, we may post another out-of-class position until a permanent hire is made.		
Guest Speaker: Michael Singleton Topic: Honor Flights	Guest speaker Timothy Smith was not present; Michael Singleton, President of Honor Flight Bay Area Foundation, attended in his place. He presented while the accompanying presentation was shown and stated that the organization, founded in 2014, transports veterans from World War II, Korea, and Vietnam to Washington, D.C., to visit memorials honoring their service.		
	Discussion/Q&A followed.		
Sub-Committee Reports	 Outreach: Edgar Reyes, Veterans Outreach Specialist for the Veterans First Program at Las Positas College, mentioned the upcoming events they will be hosting, which include: A Veterans Summit, facilitated by the Veterans First Program and hosted by Alameda County Behavioral 		

- Health, is a free event scheduled for January 26, 2026, at Las Positas College in Livermore, CA.
- o Trunk or Treat on October 28, 2025.
- Veterans Day event on November 6, 2025, with guest speaker Dr. Harold Strunk.

Commissioner Owens mentioned the following outreach opportunities:

 Operation Green Light (November 3–11): Change an exterior light to a green bulb in recognition of veterans.

> Executive:

The Executive Meeting was held on October 6, and various topics were discussed, including the Stand Down, Honor Flight guest speaker, Veteran Observance Days, the Nomination Committee, Legislative Affairs, Veteran Memorial Buildings, membership, the Board of Supervisors meeting, and topics for October.

Veteran Observance Days:

Commissioner Owens highlighted upcoming Veterans
 Observances: October 26 – National Day of Deployment;
 November – National Veterans and Military Families
 Month; November 10 – U.S. Marine Corps Anniversary;
 and November 11 – Veterans Day.

> Veteran Memorial Building:

- Commissioner Williamson discussed their efforts to have certain veterans memorial buildings/senior centers officially recognized as veterans buildings.
- She read an email from a fellow veteran inviting others to the North Oakland Senior Center, located at 5714 Martin Luther King Jr. Way, this coming Thursday at 9 a.m., to support efforts to eliminate the veterans committee at the senior center.

> PAL Legislation:

- Commissioner Phair stated they will hold a meeting to draft a proposal asking the Board of Supervisors to formally endorse SB 694, which assists veterans in obtaining their benefits. Commissioner Phair stated he is awaiting the governor's clarification on which bills were passed.
- AB 54, which excludes disability income from determining a veteran's eligibility for court fee waivers, was signed by the governor.
- AB 88 allows dependents of California active-duty service members stationed out of state to remain eligible for Cal Grants was passed.
- AB 81, which would have established a mental health study for women veterans, was vetoed by the Governor.
- AB 1509, which creates the California State Accrediting Agency for Veterans Education (CSAAVE) within the

- California Department of Veterans Affairs (CalVet), has passed and was chaptered into law.
- AB 1508, which reestablishes the Veterans' Military Advisory Committee following its recent expiration, has passed and is now extended for another 10 years.

> Stand Down:

- Slides of the Stand Down event were presented, and Commissioner Owens provided explanations for each slide.
- Commissioner Owens explained that various vendors participated, including DAV (which had its own room) the Department of Veterans Affairs, a barbershop, the VA Health Care System, and Child Support, among others.
- A total of 176 veterans attended, representing various locations. The breakdown by branch of service was: 79 Army, 50 Navy, 23 Air Force, 18 Marine Corps, 2 Coast Guard, and 4 unidentified.
- The Alameda County Treatment Court was a huge success, serving 32 veterans. A total of 135 cases were resolved, including 75 criminal cases and 60 traffic cases.

> Membership:

 Commissioner Owens announced that Robert Hart is the newest member of the commission, bringing its full membership to 22.

> Nomination:

- Commissioner Yohannes reiterated that the Nomination Committee consists of Nate Harrison, Sheweet Yohannes, and Bob Cole.
- Commissioner Yohannes mentioned that voting for Chair and Vice Chair will take place next month and noted that members can email the Nomination Committee with their nomination suggestions.
- Commissioner Yohannes reminded everyone that Commissioner Farmer nominated himself and Commissioner Yohannes for Chair.
- Commissioner Yohannes noted that there are currently no nominations for Vice Chair.
- Commissioner Yohannes mentioned that anyone being nominated will be informed and must accept the nomination before being placed on the slate.

ORAL COMMUNICATION/ANNOUNCEMENTS

The next meeting will be held at the Alameda County Memorial Building on November 17.

Commissioner Reed discussed holding a meeting at the Oakland Memorial Building and noted progress in revitalizing the old Castro Valley library, now managed by Hayward Parks & Recreation. Commissioner Cole discussed an invitation from the Alameda Veterans Group to set aside a room at the Alameda Veterans Memorial Building,

enabling volunteer DAV chapter service officers to process claims. He also noted favorable results from the Stand Down, including a DAV Claims Information Seminar designed to inform participants about benefits they are entitled to but may not be aware of. Lastly, he shared two success stories. Commissioner Reed commented that Pleasanton will hold a parade for Veterans Day. Commissioner Williamson introduced Dawn Hill, who was present at the Stand Down and spoke about living benefits available to veterans and ways to create a legacy. Commissioner Williamson shared her testimony on how Dawn Hill assisted her and her daughter. The Veterans Luncheon will be held on November 14th at the Hayward Veterans Memorial Building. Meeting adjourned at 11:59 pm. **ADJOURNMENT**
