- Met with Board President, Keith Carson during retreat to identify opportunities for the HRC to contribute to the County's Vision 2026 process.
- Sponsored virtual Tri-City Interfaith Council 'Day of Harmony' Event (February 6, 2021).

Accomplishments-continued:

- Collaborated with Alameda County Health Care for the Homeless to provide COVID-19 vaccines and other services at a Walk-up Community Care Site at Raimondi Park, Oakland (May 17, 2021).
- Presented first virtual Excellence in Human Relations Award (March 18, 2021).



Focuses on increasing visibility and implementation of the Anti-Racism in Public Health Act of 2021.

Conducts listening sessions and works to identify areas of greatest disparity.

Community Engagement

Increases profile and understanding of the HRC. One example: coordinating the Annual Excellence in Human Relations Awards event.
