#### Topic 1:

Review of Alameda County Vision 2026

- Chair Johnson asked the commission how can the HRC support the 10x goals for the
  county and how the goals tie into committee goals. Creating a calendar would be
  successful by listing commission activities and re-staring some of the past commission
  community activities. Chair Johnson, Thanks commission Dwin on his services to
  feeding the community.
- Chair Johnson states the commission is in alignment with supporting the homelessness and employment for all. HRC could work on volunteering with employment agencies to help the homeless find jobs.
- Chair Johnson, would like if Commissioner Maxey could help provide a list of organizations the HRC can invite to speak on homelessness and employment.
- Commissioner Monfared, suggest nailing down plan of what the commission would like to do.
- Commissioner Borjon suggest evaluating our resources to see how the commission can support with the county 10x goals by serving food to the homeless. Noted that the Commission on the Status of Women has a program for incarcerated woman and that the HRC may be able to help.
- Commissioner Thomas, suggest reaching out to non-profits on how the HRC can help promote their services in the community. Commissioner Thomas suggest forming a resume template and having the HRC help resident write resumes. Chair Johnson suggested Commissioner Thomas the HRC could look into organizations doing that work and having the HRC support those organizations.

- Commissioner Danielson-Chang mentions how health care for all ties into homeless and health and safety that would have a behavior health focus. Commissioner Danielson-Chang will work with commissioner Monfared on integrating a behavior health focus into HRC goals.
- Commissioner Medeiros, suggest narrowing the focus to ensure the commission can be successful in reaching goals. Possibly have the commission focus on the homeless pregnant population
