Subject: Status of Being a Commissioner on the ACVAC

Mr. Parshall,

I'd like to thank you for your service to the Commission. However, we have only had your presence at two of our monthly meetings in 2023. I've also reached out to you via phone call 3 times since we last saw you at our meeting at Swords to Plowshares last spring and have not heard back. In accordance with bylaw section 6a:

"Failure to attend meetings: A Commissioner may be terminated for failure to attend (3) or more regular meetings in a calendar year. The Chairperson of the Commission shall have the authority to excuse not more than two absences per member per year upon finding extraordinary circumstances."

Moreover, per bylaw section 7a-b, I'm again inviting you to join us at our Feb 20th, 2023 Executive Committee meeting from 9:30-10 am at Chabot College at 25555 Hesperian Boulevard, Hayward, CA 94545 to discuss the status of your membership.

If you're not present per bylaw section 7c, I'll inform you in writing of our decision within 5 calendar days of the meeting. If the Executive Committee votes to remove you from the Commission, you may ask the full Commission to review your removal. You must do so within ten days of our decision via written request to myself, another Commissioner, or a member of the staff, requesting that the full Commission review your removal at our next regular meeting. At that time, you'll be given a reasonable opportunity to speak. If, at that meeting, the full Commission ratifies your removal, you may also ask the Board of Supervisors to review that decision. You must request them in writing within 10 days of that decision to do so at their next regular meeting.

Per section 4 of our bylaws, if you'd like to resign, you may send me a written notice via USPS or email at ofarmer@hotmail.com or mail me a hard copy to 3758 Grand Ave #12 Oakland, CA 94610. I can also be reached via phone at (415) 513-8024.

Section 4.

Term of Office and Resignations

All Commissioners shall serve for three (3) year terms at the pleasure of the Board of Supervisors with a maximum of 12 successive years. Any vacancy on the Commission shall be filled by the Board of Supervisors in the same manner as the original appointment. Any person appointed to fill a vacancy shall serve for the unexpired term of the member he or she succeeds.

- a. No Commissioner shall be reappointed to the Commission until three (3) years after the termination of his or her twelfth (12th) successive year.
- b. Any Commissioner may resign by giving written notice to the Chairperson of the Commission. The resignation shall be effective when the notice is given.

Section 5. Authorized Absence

The Executive Committee shall allow a leave of absence for a Commissioner not to exceed a period of six (6) months with proper documentation. Any approved leave shall not toll the time on the Commissioner's three-year appointment term.

Section 6. Removal of Commissioners

A Commissioner may be terminated by resignation, death, incapacity, or removal. The Executive Committee may remove a member for failure to regularly attend scheduled meetings or for conduct detrimental to the interests of the Commission.

- a. Failure to attend meetings: A Commissioner may be terminated for failure to attend three (3) or more regular meetings in a calendar year. The Chairperson of the Commission shall have the authority to excuse not more than two absences per member per year upon finding extraordinary circumstances.
- b. Conduct detrimental to the interests of the Commission:
 - i. No member of the Commission shall utilize commission stationary to communicate with the public, governmental, or private entities without the express approval of the full Commission and the Board of Supervisors.
 - ii. No Commissioner shall make verbal or written statements as a sub-committee member or Commissioner that leads anyone to believe that he or she is speaking on behalf of the Commission without the express approval of the Commission at an authorized meeting and duly recorded in the minutes of that meeting.
 - iii. No Commissioner or member of the Commission and any of its employees shall solicit funds on behalf of the Commission without the approval of the Board of Supervisors.
 - iv. No Commissioner or member of the Commission and any of its employees shall, in the performance of their duties as Commissioner, participate in or take part in, including but not limited to publishing or distributing statements, any political campaign on behalf of any candidate for public office.

Section 7. Procedure for Removal

The Executive Committee may remove a Commissioner based on the criteria defined above. To remove a member, the Executive Committee shall follow the following procedures:

- a. The Commissioner in question shall be given notice not less than fourteen (14) days prior to the meeting at which the Executive Committee will vote on his/her removal. This notice shall be:
 - i. In writing, detailing the time and place of the meeting where such action will be taken; and
 - ii. Mailed to the Commissioner in question with a return receipt requested.
- b. The Commissioner in question shall be given reasonable opportunity to speak before the Executive Committee; however, failure to appear before the Executive Committee shall not be an impediment to the removal action.
- c. A Commissioner may be removed by a majority vote of the Executive Committee members present, provided that a quorum is present, and that the quorum includes the Chairperson or Vice-Chairperson. If the Commissioner is not present, the Chairperson shall inform the Commissioner in writing of the Executive Committee's decision within five (5) calendar days of the meeting. A Commissioner who is removed by the Executive Committee may ask the full Commission to review his/her removal. To do so, the Commissioner must, within ten (10) calendar days of the decision, make a written request that the Commission review his/her removal at its next regular meeting. The Commissioner shall be given a reasonable opportunity to speak. Unless a majority of a quorum of the Commission (not counting the Commissioner whose continued membership is at issue) ratifies the decision of the Executive Committee, the Commissioner may complete his/her term as a Commissioner. If the Commissioner is not present, the Chairperson shall inform the Commissioner in writing of the Commission's decision within five (5) calendar days of the meeting.

If the Commission ratifies removal of a Commissioner, the Commissioner may ask the Board of Supervisors to review the Commission's decision. To do so, the Commissioner must, within ten (10) calendar days of the decision, make a written request that the Board of Supervisors review his/her removal at its next regular meeting of the Board of Supervisors. Unless the Board of Supervisors ratifies the Commission's decision by majority vote, the Commissioner may complete his/her term as a Commissioner.

**SUBJECT: APPROVAL OF ALAMEDA COUNTY VETERANS AFFAIRS COMMISSION
BYLAWS AND RELATED COUNTY ORDINANCE**

Dear Board Members:

RECOMMENDATION:

- A. Approve an ordinance amending section 2.92.030 of the Administrative Code of the County of Alameda relating to the Alameda County Veterans Affairs Commission, broadening representation from all veteran associations and foreign wars with the inclusion of two additional voting positions from 1) Military Officers Association of America and 2) Iraq/Afghanistan Veterans of America; and
- B. Approve the changes in the Veterans Affairs Commission Bylaws, which conform to the proposed Ordinance change.

DISCUSSION/SUMMARY:

This letter requests action by your Board to approve the changes to County Ordinance 2.92.030 and related Veterans Affairs Commission Bylaws recommended by its members. The changes referenced below, incorporate the requirement of representatives from the Military Officers Association of America and Iraq/Afghanistan Veterans for the formation of its commission.

I. Section 2.92.030 - Composition of the commission.

Two representatives of the American Legion; two representatives of the Veterans of Foreign Wars; two representatives of the Vietnam Veterans of America; two representatives of Disabled American Veterans; one representative of American Veterans of Wars, AMVETS; two representatives of Women Veterans (Members at Large); **one representative of the Marine Corp League; one representative of the Iraq/Afghanistan Veterans of America; one representative of the Military Officers Association of America;** one representative of District 1 (Member at Large); one representative of District 2 (Member at Large); one representative of District 3 (Member at Large); one representative of District 4 (Member at



Large); one representative of District 5 (Member at Large); two representatives of veterans who are not otherwise affiliated with a chartered veteran's organization (Members at Large); and one non-veteran representative of widows and dependents of veterans that is a non-voting advisory position (Member at Large).

- II. Appointments to the Commission shall be made by the board of supervisors from recommendations made by the district commanders of the respective organizations named in part A, except in the cases of the five veterans identified as representing Districts 1 through District "5. Those appointments shall be chosen and made by the board of supervisors. In addition, the board of supervisors shall appoint, based upon recommendations by the Commission, the following: two at-large positions of veterans who are not affiliated with a chartered veteran's organization, and one non-voting, non-veteran at-large position representing widows and dependents of veterans.



AN ORDINANCE AMENDING SECTION 2.92.030 OF THE ADMINISTRATIVE CODE OF THE COUNTY OF ALAMEDA RELATING TO THE ALAMEDA COUNTY VETERANS AFFAIRS COMMISSION

The Board of Supervisors of the County of Alameda ordains as follows:

Section 2.92.030 of the Administrative Code of the County of Alameda is amended to read:

Section 2.92.030 – Composition of the commission.

- A. Two representatives of the American Legion; two representatives of the Veterans of Foreign Wars; two representatives of the Vietnam Veterans of America; two representatives of Disabled American Veterans; one representative of American Veterans of Wars, AMVETS; two representatives of Women Veterans (Members at Large); one representative of the Marine Corp League; one representative of the Iraq/Afghanistan Veterans of America; one representative of the Military Officers Association of America; one representative of District 1 (Member at Large); one representative of District 2 (Member at Large); one representative of District 3 (Member at Large); one representative of District 4 (Member at Large); one representative of District 5 (Member at Large); two representatives of veterans who are not otherwise affiliated with a chartered veteran's organization (Members at Large); and one non-veteran representative of widows and dependents of veterans that is a non-voting advisory position (Member at Large).
- B. Appointments to the Commission shall be made by the board of supervisors from recommendations made by the district commanders of the respective organizations named in part A, except in the cases of the five veterans identified as representing Districts 1 through District 5. Those appointments shall be chosen and made by the board of supervisors. In addition, the board of supervisors shall appoint, based upon recommendations by the Commission, the following: two at-large positions of veterans who are not affiliated with a chartered veteran's organization, and one non-voting, non-veteran at-large position representing widows and dependents of veterans.

**ALAMEDA COUNTY
VETERANS AFFAIRS COMMISSION
BYLAWS**

ARTICLE 1

Name of the Commission

The name of the commission shall be "Alameda County Veterans Affairs Commission," hereafter referred to as the ACVAC.

ARTICLE 2

Offices of this Commission

The office for the ACVAC is located at the Alameda County Social Services Agency, Department of Adult & Aging Services, located at 6955 Foothill Boulevard, Suite 300, Oakland, California 94605-2405.

ARTICLE 3

Purpose and Responsibilities

Section 1. General Purpose

The ACVAC is appointed by the County of Alameda Board of Supervisors to advise and assist the Board of Supervisors on matters relating to veterans and their families as may pertain to meeting their basic needs for veteran's benefits, food, shelter, transportation, and employment.

Section 2. Specific Duties

In order to achieve its general purpose, the ACVAC shall among other things:

- a. Assist in all veterans' observance days during the year;
- b. Promote, develop, and identify the needs of the veterans and their families;
- c. Submit recommendations to the Board of Supervisors regarding programs, plans, goals, policy, and procedures dealing with veteran services;
- d. Review annually the status of veterans' benefits;
- e. Study, investigate, and research veterans' matters in the County of Alameda so that services to veterans can be coordinated and maximized.

ARTICLE 4

ACVAC Membership

Section 1. Appointments

Appointments to the ACVAC shall be made by the Board of Supervisors from recommendations made by the District Commanders of the respective chartered veteran's organizations named in Section 2, except in the cases of the five (5) veterans identified as representing Board of

veteran also must have been honorably discharged from a military service per § 3(a) above and must provide proof of honorable discharge to the ACVAC Chairperson.

Section 4. Term of Office and Resignations

All Commissioners shall serve for three (3) year terms at the pleasure of the Board of Supervisors with a maximum of twelve (12) successive years or until the Board of Supervisors has appointed their successor but not more than six (6) months from the expiration of their term. Any vacancy on the Commission shall be filled by the Board of Supervisors in the same manner as the original appointment:

- (a) County of Alameda Boards, Commissions and Committees Application;
- (b) Resume’;
- (c) “Statement of Support” recommendations by the District

Any person appointed to fill a vacancy shall serve for the unexpired term of the member they succeed.

- a. No Commissioner shall be reappointed to the ACVAC until three (3) years after the termination of his or her twelfth (12th) successive year.
- b. Any Commissioner may resign by giving formal written notice i.e., “Letter of Resignation.” All resignations shall be made in writing and addressed to the ACVAC Chairperson. The “Letter of Resignation” will include the effective date of the Commissioner’s resignation and the position from which he or she is resigning.

Section 5. Authorized Absence

The ACVAC Executive Committee shall allow a leave of absence for a Commissioner not to exceed a period of six (6) months with proper documentation. Any approved leave shall not toll or exhaust the time on the Commissioner’s three (3) year appointment term.

Section 6. Removal of Commissioners

A Commissioner may be terminated by resignation, death, incapacity, or removal. The Executive Committee may remove a Commissioner for failure to regularly attend scheduled meetings or for conduct detrimental to the interests of the ACVAC.

- a. Failure to attend meetings: A Commissioner may be terminated for failure to attend three (3) or more regular meetings in a calendar year. The Chairperson of the ACVAC shall have the authority to excuse not more than two (2) absences per ACVAC member per year upon finding extraordinary circumstances.
- b. Conduct detrimental to the interests of the ACVAC:
 - (1) No Commissioner shall utilize ACVAC stationary to communicate with the public, governmental, or private entities without the expressed approval of the full ACVAC and the Board of Supervisors.
 - (2) No Commissioner shall make verbal or written statements as a committee member or commissioner that leads anyone to believe that are speaking on

within ten (10) calendar days of the decision, make a written request that the Board of Supervisors review their removal at the next regular meeting of the Board of Supervisors. Unless the Board of Supervisors ratifies the Commission's decision by a majority vote, the Commissioner may complete their term as a Commissioner.

ARTICLE 5

Meetings

Section 1. Quorum

Unless a quorum is present, no business requiring a vote of the ACVAC or any of its committees may be transacted. A quorum shall be the number of Commission members equal to or greater than 50% of the appointed voting members of the Commission. For committee meetings, a quorum shall be the number of members equal to or greater than 50% of the appointed voting members of the committee.

Section 2. Regular and Annual Meetings

- a. Regular meetings of the ACVAC shall be held each month as designated by the ACVAC. Monthly meetings may be omitted, as long as the ACVAC meets a minimum of ten (10) times per year.
- b. The ACVAC and its committees shall comply with the rules established by the Ralph M. Brown Act (Government Code Section 59450) in conducting meetings and a copy shall be provided to all ACVAC Commissioners.
- c. Agendas for regular meetings, special meetings, and meetings of all ACVAC standing committees shall specify the time and place of the meeting and shall contain a brief description of each item of business to be transacted at the meeting, including items to be discussed in closed session. At least seventy-two (72) hours prior to a meeting, staff must mail, e-mail, text or fax copies of the agenda to the Commissioners, or committee members in the case of a committee meeting. Staff must also ensure that the Agenda is posted seventy-two (72) hours in a place easily accessible to the general public; mailed or emailed to anyone who has made a written request for such notice during the current calendar year.

Section 3. Special Meetings

The ACVAC Chairperson, the Vice-chairperson or any two (2) Commissioners may call special meetings of the ACVAC. Notice for a special meeting shall be made in the same manner as for regular meetings.

Section 4. Adjourned Meetings

Regular, special, and standing committee meetings may be adjourned in compliance with the Ralph M. Brown Act. All persons who were entitled to notice of the meeting shall receive notice

Section 2. Standing Committees

- a. The standing committees of the ACVAC shall be the Executive Committee, the Membership Committee, the Community Outreach Committee, and the Budget Committee. The ACVAC may create additional standing committees by majority vote, each consisting of at least three (3) Commissioners. Additional standing committees shall be subject to the same rules and procedures as the standing committees created in these Bylaws. The standing committees shall make recommendations to the full ACVAC. The action of all committees is subject to the approval of the full ACVAC.
- b. The Chairperson shall make appointments to the committees.
- c. The Chairperson may appoint one or more committee members as alternate members of any such committee, to replace any absent member of a committee at any meeting.

Section 3. Ad-Hoc Committees

- a. Throughout the year, there are events or actions that are required by the Commission that require the creation of an ad-hoc committee. These ad-hoc committees do not continue throughout the year but are necessary for a period of time. The recurring ad-hoc committees of the Commission include: the Nomination Committee, the Bylaws Committee, and the Veterans' Observance Days Committee.
- b. The Commission may create additional ad-hoc committees by majority vote, each consisting of at least three (3) Commissioners. Additional ad-hoc committees shall be subject to the same rules and procedures as all committees created in these bylaws. The ad-hoc committees shall make recommendations to the full ACVAC. The action of all ad-hoc committees is subject to the approval of the full ACVAC.
 - (1) **Nomination Committee:** This ad-hoc committee shall be appointed annually by the Chairperson in September to propose nominations for the Chairperson and Vice-Chairperson election in November. The committee shall consist of three (3) Commissioners. The committee shall report to the ACVAC no later than the meeting in October with their nominations for the upcoming Officer election in November. The committee shall be responsible for conducting the election process at the November ACVAC meeting. The Nomination Committee shall swear in the newly elected Officers at the January ACVAC meeting.
 - (2) **Bylaws Committee:** This committee shall be responsible for the maintenance of the Commission's bylaws and for reviewing the existing bylaws' rules and principles that define the ACVAC's governing structure and function as well as the roles and responsibilities of its officers and members. The committee shall consist of three (3) Commissioners. The Bylaws Committee shall be created when updates and changes are needed or required, when there are

Section 3. Chairperson

- a. The Chairperson shall preside at all meetings of the ACVAC.
- b. The Chairperson shall determine whether there are extraordinary circumstances to warrant an excused absent of a ACVAC member.
- c. The Chairperson shall appoint a Nomination Committee in the month of September.
- d. The Chairperson shall exercise and perform such other power and duties as the ACVAC may assign.
- e. The Chairperson or a designated representative shall give the ACVAC's annual Board of Supervisor update.

Section 4. Vice Chairperson

- a. The Vice-Chairperson shall perform all duties of the Chairperson, during their absence.
- b. The Vice-Chairperson shall have all powers of and be subjected to all restrictions of the Chairperson, during their absence.
- c. The Vice-Chairperson shall have such other powers and perform such other duties as the ACVAC may assign.

**ARTICLE 8
Staffing**

The Social Services Agency shall provide, to the extent of funds are made available by the Board of Supervisors, staff, and supplies necessary to assist the ACVAC in the performance of its duties, including but not limited to the issuance of notices and agenda for all meetings and maintaining a book of the minutes for all meetings.

**ARTICLE 9
Maintenance of the Commission Records and Reports**

Section 1. The Commission shall keep:

- a. Written minutes of the proceedings of the ACVAC and its committees.
- b. A record of each Commissioner's name, address, title, and ACVAC responsibility.

Commission in which they know or has reason to know, they have a financial interest. A member of the ACVAC has a financial interest in a decision if it is reasonably foreseeable that the decision will have a material financial effect on the member or member's immediate family or in their business entity, real property, or source of income.

- d. Each Commissioner or committee member is required to disqualify themselves from participation in a decision which may have a foreseeable material financial impact on their financial interests.
- e. No Commissioner or committee member shall receive at any time any money that was donated to, raised by, or held in the name of the ACVAC.
- f. California Government Code Section 53235 requires all ACVAC Commissioners receive two (2) hours of ethics training within one (1) year of taking the "Oath of Office" and once every two (2) years thereafter.

ARTICLE 12
Rules of Order

The ACVAC shall adopt the most recent edition of Robert's Rules of Order as its parliamentary authority. Robert's Rules of Order shall apply to all questions of parliamentary procedure used at all ACVAC meetings.


ARTICLE 13
Amendments of Bylaws

Amendments of these Bylaws require a two-thirds vote of the ACVAC members at a meeting where a quorum is present. Approved amendments shall take effect once they are approved by the Board of Supervisor. Any amendments to the proposed amendments shall be handled according to the same procedures as the original amendments.

ARTICLE 14
Severability

If any part of these Bylaws is held to be null and void by any competent court of law, the remaining portion of the Bylaws shall not be affected.

Hi Greg,

Hope you had a good trip. Per the by-laws, I believe we need to initiate the Nomination Committee ASAP. Who was a part of it last year.

i. Nomination Committee: This ad-hoc committee shall be established and created in September annually, 90 days prior to the Commission's annual officer election in November, by a majority vote of the Full Commission. The purpose of the nominating committee is to propose nominations for the Commission's Chairperson and Vice-chairperson election. The committee shall consist of three (3) Commissioners. The committee shall report to the Commission no later than the meeting in October with their nominations for the upcoming Commission's officer election in November. The committee shall be responsible for conducting the election process at the November Commission meeting. The committee shall swear in the newly elected officers at the January Commission meeting.

Section 2. Standing Committees

- a. The standing committees of the ACVAC shall be the Executive Committee, the Membership Committee, the Community Outreach Committee, and the Budget Committee. The ACVAC may create additional standing committees by majority vote, each consisting of at least three (3) Commissioners. Additional standing committees shall be subject to the same rules and procedures as the standing committees created in these Bylaws. The standing committees shall make recommendations to the full ACVAC. The action of all committees is subject to the approval of the full ACVAC.
- b. The Chairperson shall make appointments to the committees.
- c. The Chairperson may appoint one or more committee members as alternate members of any such committee, to replace any absent member of a committee at any meeting.

Section 3. Ad-Hoc Committees

- a. Throughout the year, there are events or actions that are required by the Commission that require the creation of an ad-hoc committee. These ad-hoc committees do not continue throughout the year but are necessary for a period of time. The recurring ad-hoc committees of the Commission include: the Nomination Committee, the Bylaws Committee, and the Veterans' Observance Days Committee.
- b. The Commission may create additional ad-hoc committees by majority vote, each consisting of at least three (3) Commissioners. Additional ad-hoc committees shall be subject to the same rules and procedures as all committees created in these bylaws. The ad-hoc committees shall make recommendations to the full ACVAC. The action of all ad-hoc committees is subject to the approval of the full ACVAC.

✓ (1) **Nomination Committee:** This ad-hoc committee shall be appointed annually by the Chairperson in September to propose nominations for the Chairperson and Vice-Chairperson election in November. The committee shall consist of three (3) Commissioners. The committee shall report to the ACVAC no later than the meeting in October with their nominations for the upcoming Officer election in November. The committee shall be responsible for conducting the election process at the November ACVAC meeting. The Nomination Committee shall swear in the newly elected Officers at the January ACVAC meeting.

(2) **Bylaws Committee:** This committee shall be responsible for the maintenance of the Commission's bylaws and for reviewing the existing bylaws' rules and principles that define the ACVAC's governing structure and function as well as the roles and responsibilities of its officers and members. The committee shall consist of three (3) Commissioners. The Bylaws Committee shall be created when updates and changes are needed or required, when there are

✓ **Section 3. Chairperson**

- a. The Chairperson shall preside at all meetings of the ACVAC.
- b. The Chairperson shall determine whether there are extraordinary circumstances to warrant an excused absent of a ACVAC member.
- c. The Chairperson shall appoint a Nomination Committee in the month of September.
- d. The Chairperson shall exercise and perform such other power and duties as the ACVAC may assign.
- e. The Chairperson or a designated representative shall give the ACVAC's annual Board of Supervisor update.

✓ **Section 4. Vice Chairperson**

- a. The Vice-Chairperson shall perform all duties of the Chairperson, during their absence.
- b. The Vice-Chairperson shall have all powers of and be subjected to all restrictions of the Chairperson, during their absence.
- c. The Vice-Chairperson shall have such other powers and perform such other duties as the ACVAC may assign.

ARTICLE 8
Staffing

The Social Services Agency shall provide, to the extent of funds are made available by the Board of Supervisors, staff, and supplies necessary to assist the ACVAC in the performance of its duties, including but not limited to the issuance of notices and agenda for all meetings and maintaining a book of the minutes for all meetings.

ARTICLE 9
Maintenance of the Commission Records and Reports

Section 1. The Commission shall keep:

- a. Written minutes of the proceedings of the ACVAC and its committees.
- b. A record of each Commissioner's name, address, title, and ACVAC responsibility.



CACVSO LEGISLATIVE REPORT-END OF 2023 LEGISLATIVE YEAR; OCTOBER 14, 2023

The California State Legislature adjourned for the 2023 legislative year on September 14. Legislation that survived the legislative process to that point were sent to the Governor for his signature or veto. The Governor had until October 14 to review all of those bills and sign or veto. Below is a listing of the bills that were signed in to law by the Governor. No bills that were supported by the CACVSO were vetoed.

Since 2023 is the first year of the 2023-24 legislative session, next year will have a combination of “2-year bills” and “Second-year bills”.

- **2-Year Bills:** Bills introduced in the first year of the session can be carried over in to the next year, provided they did not fail passage in a committee. Usually, these bills were “parked” in their house of origin because it was found they needed more time for the various parties to the bill to work out the bugs, reach agreements, work on amendments, etc. These bills need to pass out of their house of origin by January 31 of the second year. If a bill made it out of its house of origin in the first year, then was parked, it is not constrained by the January 31 deadline in the second year.
- **Second-year bills:** New legislation may be introduced in the second year of the session. These bills only have that one year to move through the process. There is no 2-year option for these bills. All legislation that did not advance to the Governor by the end of the legislative year automatically dies.

AB 46-Ramos, the bill that sought to exempt military retirement pay and SBP from the state income tax was held under Submission in the Senate Appropriations Committee on September 1. Normally, this action is a de facto death sentence for a bill. However, in the case of AB 46, the Governor’s Department of Finance (DOF) indicated to the author that the bill idea had merit, but a way needs to be found to reduce the hit to the state’s revenues. Assemblyman Ramos has committed to working next year to find a solution in the budget process or some other way to alleviate DOF’s concerns. AB 46 is not bound by the January 31 deadline since it passed its house of origin and is in the Senate. CACVSO is in support of AB 46.

AB 298

(Mathis R) Honoring Our Blind Veterans Act.

Status: 10/4/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 299, Statutes of 2023.

Location: 10/4/2023-A. CHAPTERED

Summary: Current law would authorize a nonprofit organization that represents blind veterans, in consultation with the Department of General Services, to plan, construct, and maintain a braille American flag to serve as a monument to the blind veterans of California and the United States in the State Capitol Building. The bill would specify duties for the Department of General Services in connection with the planning, construction, and maintenance of the monument. The bill would prohibit the construction of the monument until the Joint Rules Committee of the California Legislature approves and adopts a plan for the monument and the committee and the Department of Finance determine that sufficient private funding is available to construct and maintain the monument.

AB 322

(Mathis R) Veteran and California National Guard Supplemental Orientation Act of 2023.

Status: 10/13/2023-Approved by the Governor. Chaptered by Secretary of State. Chapter 801, Statutes of 2023.

Location: 10/13/2023-A. CHAPTERED

Summary: Would, commencing no later than the 2025-26 academic year, would require each campus of the California State University and the California Community Colleges, and would request each campus of the University of California, to include within first-year student and transfer student orientations the location and contact information of the campus point of contact for students who are veterans of the Armed Forces of the United States and members of the California State Guard and the California National Guard, and their dependents, make available in hard copy form at the location of the campus point of contact a document that includes information on polices, resources, and services for these students and their dependents, as specified, and post the document, along with other information available to these students and their dependents, on the campus's internet website.

AB 531

(Irwin D) The Behavioral Health Infrastructure Bond Act of 2023.

Status: 10/12/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 789, Statutes of 2023.

Location: 10/12/2023-A. CHAPTERED

Summary: Would provide that projects funded by the Behavioral Health Infrastructure Bond Act of 2024 that provide housing for individuals and families who are experiencing homelessness or who are at risk of homelessness and who are inherently impacted by or at increased risk for medical diseases or conditions due to the COVID-19 pandemic or other communicable diseases and are disbursed in accordance with the Multifamily Housing Program, or projects that are disbursed in accordance with the Behavioral Health Continuum Infrastructure Program, are a use by right and subject to the streamlined, ministerial review process. The bill would define use by right for these purposes to mean that the local government's review of the project does not require a conditional use permit, planned unit development permit, or other discretionary local government review or approval that would constitute a project subject to the approval process in CEQA.

AB 569

(Garcia D) California State University: Cybersecurity Regional Alliances and Multistakeholder Partnerships Pilot Program.

Status: 7/27/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 117, Statutes of 2023.

Location: 7/27/2023-A. CHAPTERED

Summary: Current law requires the office of the Chancellor of the California State University to select any number of California State University campuses, with preference given to campuses that have or are developing regional pipeline programs in cybersecurity with the California Community Colleges, to participate in the pilot program through an application and selection process. Current law requires each selected campus to create a pilot program with goals and metrics, measure the impact and results of its pilot program, and annually share the impact and results with the chancellor's office. Current law requires the chancellor's office to annually report the impact and results from each selected campus's pilot program to the Legislature. This bill would require the chancellor's office, on or before July 1, 2028, to submit a report to the Legislature on the pilot program, as provided.

AB 883

(Mathis R) Business licenses: United States Department of Defense SkillBridge program.

Status: 10/7/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 348, Statutes of 2023.

Location: 10/7/2023-A. CHAPTERED

Summary: Existing law establishes the Department of Consumer Affairs under the direction of the Director of Consumer Affairs and sets forth its powers and duties relating to the administration of the various boards under its jurisdiction that license and regulate various professions and vocations. This bill would additionally require, on and after July 1, 2024, a board to expedite, and authorize a board to assist, in the initial licensure process for an applicant who supplies satisfactory evidence to the board that the applicant is an active duty member of a regular component of the Armed Forces of the United States enrolled in the United States Department of Defense SkillBridge program, as specified, and would provide that regulations to administer those provisions be adopted in accordance with the rulemaking provisions of the Administrative Procedure Act. This bill contains other existing laws.

AB 988

(Mathis R) Miles Hall Lifeline and Suicide Prevention Act: veteran and military data reporting.

Status: 10/8/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 460, Statutes of 2023.

Location: 10/8/2023-A. CHAPTERED

Summary: Current federal law, the National Suicide Hotline Designation Act of 2020, designates the 3-digit telephone number "988" as the universal number within the United States for the purpose of the national suicide prevention and mental health crisis hotline system operating through the 988 Suicide and Crisis Lifeline, maintained by the Assistant Secretary for Mental Health and Substance Use, and the Veterans Crisis Line, which is maintained by the Secretary of Veterans Affairs. Current law creates a separate surcharge, beginning January 1, 2023, on each access line for each month, or part thereof, for which a service user subscribes with a service supplier. Existing law sets the 988 surcharge for the 2023 and 2024 calendar years at \$0.08 per access line per month and beginning January 1, 2025, at an amount based on a specified formula not to exceed \$0.30 per access line per month. Current law authorizes the 911 and 988 surcharges to be combined into a single-line item, as described. Existing law provides for specified costs to be paid by the fees prior to distribution to the Office of Emergency Services. The Miles Hall Lifeline and Suicide Prevention Act creates the 988 State Suicide and Behavioral Health Crisis Services Fund and requires the fees to be deposited along with other specified moneys into the fund. This bill would require an entity seeking moneys from the fund to also include the number of individuals who used the service and self-identified as veterans or active military personnel in its annual expenditure and outcomes report.

AB 1350

(Soria D) Veterans: memorials.

Status: 10/10/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 684, Statutes of 2023.

Location: 10/10/2023-A. CHAPTERED

Summary: Would create the Capitol Park Veterans Memorial Fund. The bill would continuously appropriate the fund to the Department of Veterans Affairs for the purpose of the maintenance and rehabilitation of existing memorials in the State Capitol. The bill would make the department responsible for administering the fund. The bill would require the Department of Veterans Affairs to, in consultation with the California Veterans Board, prioritize memorials that do not have formal support from another body for their maintenance, including, but not limited to, the Vietnam Veterans Memorial. The bill would require the Department of Veterans Affairs and the Department of General Services to collaborate pursuant to a memorandum of agreement to carry out these provisions.

AB 1361

(Hoover R) Property taxation: veteran's exemption: preliminary application.

Status: 10/8/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 473, Statutes of 2023.

Location: 10/8/2023-A. CHAPTERED

Summary: Current property law, pursuant to the authorization of the California Constitution, provides a disabled veteran's tax exemption on specified property, as described. Current law sets forth procedures to claim property tax exemptions. This bill would authorize a county assessor to provide written or electronic determination of preliminary eligibility for the disabled veteran's tax exemption. The bill would make related findings and declarations. This bill would incorporate additional changes to Section 205.5 of the Revenue and Taxation Code proposed by SB 82 to be operative only if this bill and SB 82 are enacted and this bill is enacted last.

AB 1386

(Gabriel D) Veterans housing: tenant referrals.

Status: 10/11/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 760, Statutes of 2023.

Location: 10/11/2023-A. CHAPTERED

Summary: The Veterans Housing and Homeless Prevention Act of 2014 requires the California Housing Finance Agency, the Department of Housing and Community Development, and the Department of Veterans Affairs (referred to collectively as “the departments”) to establish and implement programs that focus on veterans at risk for homelessness or experiencing temporary or chronic homelessness, as specified. In this regard, current law requires the departments to establish and implement programs that, among other things, ensure projects combine housing and supportive services. Current law requires the departments to ensure at least 50% of funds awarded for capital development are used to provide housing to veterans with extremely low incomes, and requires that at least 60% of units funded targeting extremely low income households are supportive housing. This bill would authorize an entity tasked with making referrals of units targeted to extremely low income households to submit a petition to the departments requesting authority to lease the qualified unit to a secondary tenant, as defined, if a qualified entity is unable to locate, match, or otherwise place a qualified tenant in a qualified unit with 60 days of the unit becoming available. The bill would require a qualified unit that is leased to a secondary tenant to be redesignated to an area median income level commensurate with the income level of the secondary tenant and would require the secondary tenant to pay rent commensurate with their household income’s percentage of the area medium income. The bill would, 12 months after a petition is approved, require the next available comparable unit to be rented to a qualified tenant at 30% of the median income.

AB 1452

(Mathis R) State Capitol: Iraq Afghanistan Kuwait Veterans Memorial monument.

Status: 10/7/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 371, Statutes of 2023.

Location: 10/7/2023-A. CHAPTERED

Summary: Existing law provides for various memorials and monuments on the grounds of the State Capitol. Existing law requires the Department of General Services to maintain state buildings and grounds. This bill would authorize a nonprofit organization representing veterans of the wars in Iraq, Afghanistan, and Kuwait in consultation with the Department of General Services, to plan, construct, and maintain a monument to the veterans of the wars in Iraq, Afghanistan, and Kuwait on the grounds of the State Capitol. The bill would require the nonprofit organization to submit a plan for the monument to the Joint Rules Committee for its review and approval. The bill would require the monument to be funded exclusively from private sources. This bill contains other related provisions and other existing laws.

AB 1462

(Patterson, Jim R) Veteran overdose deaths.

Status: 10/13/2023-Signed by the Governor

Location: 10/13/2023-A. CHAPTERED

Summary: Current law requires that each death be registered with the local registrar of births and deaths in the district in which the death was officially pronounced or the body was found. Current law sets forth the persons responsible for completing the certificate of death and the required contents of the certificate, including, but not limited to, the decedent’s name, sex, and birthplace. Current law requires a person completing the certificate of death to record whether the decedent was ever in the Armed Forces of the United States. Current law also requires the State Department of Public Health to access data within the electronic death registration system to compile a report on veteran suicide in California and requires the department to annually provide that report to the Legislature and the Department of Veterans Affairs. This bill would require the State Department of Public Health to access data within the electronic death registration system to compile a report on veteran drug overdose deaths in California and require the department to annually provide that report to the Legislature and the Department of Veteran Affairs on or before March 15 each year.

AB 1474

(Reyes D) California Statewide Housing Plan.

Status: 10/11/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 762, Statutes of 2023.

Location: 10/11/2023-A. CHAPTERED

Summary: Current law establishes the California Statewide Housing Plan, developed in cooperation with the private housing industry, regional and local housing and planning agencies, and other agencies of the state, to serve as a state housing plan. Current law requires the plan to incorporate specified segments, including, among others, a housing

strategy that coordinates the housing assistance and activities of state and local agencies, including the provision of housing assistance for various population groups, including, but not limited to, elderly persons, persons with disabilities, and other specific population groups as deemed appropriate by the department. This bill would add veterans to the list of population groups included in the housing strategy described above. The bill would require the department to also consult with the Department of Veterans Affairs in developing the housing strategy, to the extent possible. This bill would incorporate additional changes to Section 50423 of the Health and Safety Code proposed by AB 1764 to be operative only if this bill and AB 1764 are enacted and this bill is enacted last.

AB 1566

(Soria D) Department of Veterans Affairs: veterans' services.

Status: 10/10/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 694, Statutes of 2023.

Location: 10/10/2023-A. CHAPTERED

Summary: Current law requires the Department of Veterans Affairs to disburse funds, appropriated to the department for the purpose of supporting county veterans service officers pursuant to the annual Budget Act, on a pro rata basis, to a county that complies with certain conditions. Current law requires the department to prepare an annual report of the activities of county veterans services officers, including the number of claims filed to receive pension benefits and a summary of other services provided by county veterans service officers. This bill would require the department's annual report to include the composition of staff at the county office, as specified, and the annual funding of the county veterans service office by the county, as specified. This bill would authorize the department to require county veterans service officers to apply uniform measurement and workload units, claims, and other information.

AB 1605

(Gallagher R) High schools: military services: United States Space Force.

Status: 9/1/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 142, Statutes of 2023.

Location: 8/29/2023-A. CHAPTERED

Summary: Current law prohibits each school district offering instruction in any of grades 9 to 12, inclusive, that provides on-campus access to employers, from prohibiting access to the military services. Existing law defines "military services" for these purposes to include the United States Army, the United States Navy, the United States Air Force, the United States Marine Corps, the United States Coast Guard, or any reserve component of those federal forces, the National Guard, the State Guard, and the active militia. This bill would additionally prohibit each county office of education and charter school offering instruction in any of grades 9 to 12, inclusive, that provides on-campus access to employers, from prohibiting access to the military services. The bill would expressly include the United States Space Force in that definition.

AB 1745

(Soria D) Public postsecondary education: veterans: waiver of mandatory systemwide tuition and fees.

Status: 10/10/2023-Approved by the Governor. Chaptered by Secretary of State - Chapter 695, Statutes of 2023.

Location: 10/10/2023-A. CHAPTERED

Summary: The Donahoe Higher Education Act prohibits campuses of the segments of the public postsecondary education system in the state from charging mandatory systemwide tuition or fees to specified students who apply for a waiver, including a child of any veteran of the United States military who has a service-connected disability, has been killed in service, or has died of a service-connected disability, where the annual income of the child, including the value of any support received from a parent, does not exceed the national poverty level. This bill would instead require that the annual income of the child not exceed the state poverty level, as defined. The bill would also make nonsubstantive changes to provisions relating to this waiver of mandatory systemwide tuition and fees. To the extent these provisions would add additional duties on community college districts, the bill would impose a state-mandated local program.

(Sevarto R) Property taxation: disabled veterans' exemption: eligibility letters.

Status: 10/11/2023-Approved by the Governor. Chaptered by Secretary of State. Chapter 773, Statutes of 2023.

Location: 10/11/2023-S. CHAPTERED

Summary: Current property tax law provides, pursuant to the authorization of the California Constitution, a disabled veteran's property tax exemption for the principal place of residence of a veteran or a veteran's spouse, including an unmarried surviving spouse, if the veteran, because of an injury incurred in military service, is blind in both eyes, has lost the use of 2 or more limbs, or is totally disabled, as those terms are defined, or if the veteran has, as a result of a

service-connected injury or disease, died while on active duty in military service. This bill would require a county assessor to accept an electronically generated letter of service-connected disability, as defined, in lieu of an original letter of service-connected disability, at the discretion of the claimant, for purposes of verifying eligibility for the above-described exemption.

(Roth D) Civilian youth opportunities program.

Status: 10/10/2023-Approved by the Governor. Chaptered by Secretary of State. Chapter 703, Statutes of 2023.

Location: 10/10/2023-S. CHAPTERED

Summary: Current law authorizes the Adjutant General to conduct a civilian youth opportunities program, known as the "National Guard Youth Challenge Program," consisting of a residential program and post-residential mentoring to serve at-risk teens in areas of the state, including, but not limited to, the San Joaquin Valley and northern California, as specified. This bill would require the Adjutant General to additionally conduct that program in western Riverside County.






Challenges

- ▶ Low VSO staffing continues to be a challenge vs. the size of the customer base
- ▶ High stress job vs. high performance standards and recurring accreditation requirements make employee recruitment and retention difficult
- ▶ Lobby logistics – no separate VSO service center as is neighboring counties
- ▶ Access to resources (affordable housing, medical, dental, mental health) continue to be a barrier for veterans in Alameda County.

Consequences

- ▶ Inaccessibility to VA benefits including health care, mental health treatment, and dependents benefits, all translate into lost revenue spent in the county
- ▶ Increased rate of veterans unhoused
- ▶ Increased rate of incarcerated veterans equals decreased public safety
- ▶ Higher unemployment rates within the veteran community
- ▶ Untreated mental health challenges contributes to an increased suicide rate.





Dear NCBVO Chairperson Charles Blatcher III,

The Alameda County Veterans Affairs Commission issues this Letter of Support for your endeavor to have the City of Oakland spearhead and fund the street renaming process after three local Black veterans. Including their hosting of a commemorative event where the unveiling of the street names will occur.

The NCBVO Chairperson's proposal letter to rename streets after Major General John H. Sanford, Major Howard D. Jackson, and Sergeant Morrie N. Turner appropriately highlights local Black military history. As you stated during your speech to the Heritage News Network, "Black military history is the cornerstone of Black American claims for equal rights and opportunities" we need "greater representation of our military history." The aforementioned Black veterans have positively impacted lives in our nation. For example:

- The late Major General John Sanford, was the first and only Black Commanding General of the former Oakland Army Base from 1984 to 1991. In addition, he was also awarded the Defense Distinguished Service Medal, the Distinguished Superior Service Medal, and the Distinguished Flying Cross.
- Second, retired Major Howard D. Jackson is a longtime resident of Oakland. He is noted in military history for developing the first Human Relations Program in the Armed Forces in 1965. He formed and served as Executive Director of an Oakland city-chartered organization which developed initial programs to promote minority employment, housing, educational and social opportunities to improve interracial relations.
- Lastly, Sergeant Morrie Turner, served as a mechanic with the Tuskegee Airmen during World War II. He was the first Black cartoonist to work with Stars and Stripes. In 1965, Turner's comic strip Wee Pals became the first comic strip syndicated in the United States with a cast of ethnically diverse characters. In 1970, Turner became a co-chairman of the White House Conference on Children and Youth. In 2003, the National Cartoonist Society recognized his work with the Milton Caniff Lifetime Achievement Award. He was awarded numerous awards and community distinctions such as the Inter-Group Relations Award from the Anti-Defamation League and the Cartoon Art Museum's Sparky Award.

Despite being members of a historically disenfranchised group, the Black service members highlighted attained new heights regarding rank, role, or achievement. We feel the NCBVO's proposal reflects the spirit of their accomplishments and national impact and hope the City of Oakland considers renaming streets on the former Oakland Army Base and conducts an event as proposed. With Oakland being the most nationally recognized city in Alameda County, as well as home to the most veterans in the East Bay at 11,000+, ideally, this lays the foundation for an annual event to honor veterans going forward led by the City of Oakland.

VISION 2026 GOAL

This letter of support reflects the spirit of Black service member's accomplishments and will highlight local Black military history as a cornerstone to Black American's claims for equal rights and opportunities. This endeavor could empower African American individuals and communities to overcome adversities so they can grow, flourish, and be self-sufficient; and meets the shared vision of **Thriving and Resilient Communities**.

This entire area can be referred to as the Black Veteran Historical Corridor



Name A Street for A Black Veteran Oakland Army Base 1941-1999



The Oakland Army Base also known as the Oakland Army Terminal is in the San Francisco Bay area of California at the Port of Oakland just south of the eastern entrance to the San Francisco-Oakland Bay Bridge. It occupies 422 acres-consisting of 368 land acres and 54 submerged land acres.

The prospect of war with Japan was creating a sense of urgency and the U.S. Army needed a place to dispense supplies and equipment to those fighting in Asia and the Pacific Islands. Using the emergency powers act, the base was built in 1941 as part of an expansion to the San Francisco Port of Embarkation headquartered at Fort Mason on the San Francisco waterfront. It was commissioned on December 8, 1941, just one day after the attack on Pearl Harbor. Originally, the base was named The Sub-Port of the San Francisco Port of Embarkation. It was renamed the Oakland Army Base in 1944. During World War II and the Korean War, this installation moved more than 25 million tons of cargo and thousands of soldiers.

In 1946, the Oakland Army Base expanded to include the administrative and military garrison or cantonment area of the Port formerly known as Camp John T. Knight in honor of World War I Brigadier General John Thornton Knight.

In 1955, the San Francisco Port of Embarkation became the U.S. Army Transportation Terminal Command Pacific, and the Oakland Army Base became the Oakland Army Terminal.

In 1964, the headquarters of the command was moved from Fort Mason to the Oakland Army Terminal. In 1966, the terminal's name was changed back to the Oakland Army Base. During the Vietnam War, the Oakland Army Base was the largest military port complex in the world and served as a major transit station for U.S. soldiers on their way to and returning from all deployment locations in East Asia.

In June 1995, the Base Realignment and Closure Commission (BRAC) recommended the closure of the Oakland Army Base, which President Bill Clinton approved. It wasn't until September 30, 1999 that the base was officially decommissioned.

Robert Lee Toney, Rear Admiral United States Navy
Admiral Robert L. Toney Way has been designated on the former Army Base.

Robert Lee Toney was born August 30, 1934, in Monroe, Louisiana. His parents moved the family to Oakland, CA in 1942. By 1947, they moved to Oroville, CA where he attended Oroville High School from 1949 to 1952. He participated in basketball and was a member of the California Scholarship Federation for 3 years. Toney served in the California Cadets Corps where he was an officer for 2 years. He attended Youngstown University in Ohio from 1952-1954 and graduated from Chico State University in 1957 with a bachelor's degree in social science, Pre-Law. And a graduate of the National and International Security Course, Harvard University, Cambridge, MA.



His naval career spanned 34 years and included assignments as: Commander, Logistics Group One and Maritime Defense Command, and Commander , Navy Base San Francisco. His military service started in 1957 as he entered the Officer's Candidate School in Newport, Rhode Island.

In the late 60's on a tour of duty in Washington, D.C., he implemented a program to increase the number of minorities into the commissioned officers' ranks. Toney commanded two naval ships during his career, the USS Kiska; an ammunition ship from November 1975 to December 1975 and the USS Roanoke, a Wichita-class replenishment oiler from August 1983 to July of 1984.

During his time as a Rear Admiral, he was the Commander, Navy Base San Francisco and managed more than 60,000 from Monterey to the Northern California border with a payroll of about \$ 2.6 billion. His last command was a Director for Logistics and Security Assistance, U.S. Pacific Command, Camp H.M. Smith, Hawaii.

Rear Admiral Toney received many accolades for his service: the Defense Meritorious Service Medal, the Navy Meritorious Service Medal with Oak Leaf Cluster and the Vietnam Service Medal were among his medals.

He retired from the Navy in 1991 and moved his family to Oakland, CA. He believed in giving back to one's community and engaged in many activities such as United Way, the Girls and Boys Club and Urban League. From 1991 to 1996, Toney was the President and Chief Executive Officer of the Oakland Metropolitan Chamber of Commerce.

Rear Admiral Robert died on November 4, 2016, in San Francisco, CA.

John Henry Stanford, Major General United States Army

John Henry Stanford was born September 14, 1938, in Darby, Pennsylvania. He graduated from Yeadon High School and attended Pennsylvania State University, earning a Bachelor of Science degree in political science. In 1975, he earned a master's degree in personnel management and administration from Central Michigan University.

Stanford joined the U.S. Army in 1961 and trained as an infantry officer and fixed-wing aviator. He served during the Vietnam War and Operation Desert Storm. He was awarded the Distinguished Flying Cross and several Air Medals. While in the U.S. Army, he worked the acting deputy commander-in-chief and as Executive Assistant to Secretary of Defense Caspar Weinberger. He rose to the rank of major general. After 30 years in the military, he retired from the U.S. Army in 1991.



John H. Stanford joined civilian life but did not forget his years of training in the military. In 1991, Stanford began work as Manager of Fulton County Georgia. Those who worked with him applauded his leadership in cutting out bureaucracy and waste of money in county government. His next career move was perhaps his calling. In 1995, Stanford was recruited and hired as Superintendent by the largest school district in the state of Washington. He had neither previous experience as an educator nor as a superintendent. During this time, there were few non-educators hired to lead a large school district. He was Seattle's first African American superintendent.

He was known as a tireless advocate for the children and made himself available to the students by visiting the schools and interacting with the students. According to Military Wiki, Stanford believed the school system "exhibited lethargic characteristics of a monopoly..."

According to numerous sources, Stanford was a popular leader effectively reducing drop out rates and raising SAT scores during his brief tenure.

John Henry Stanford's tenure was cut short when he became ill with leukemia and died on November 28, 1998. He was buried with full military honors in Arlington and his memorial service was attended by over 2,500 people. The school district headquarter has been renamed the John Stanford Center for Educational Excellence and the Latona School renamed the John Stanford International School. The Bill and Melinda Gates Foundation donated \$2 million to the

Stanford Endowment which was established to fund teacher training and leadership programs.

Howard D. Jackson, Major: United States Marine Corps (retired)



Howard D. Jackson received a B.A. in Political Science from Michigan State University, East Lansing, Michigan in 1956. He pursued Postgraduate Studies in International Relations, Law at California State University, Fullerton, Armstrong Law College. He has more than 35 years of experience and service in government and industry.

In 1957, Mr. Jackson joined the United States Marine Corps. He served in Vietnam from November 1966 until 1967. During his 12 years and 2 months in the Marine Corps, Jackson developed the first official Human Relations Office in the Naval Services. This position became the hallmark for similar positions that are still used today. He served in that assignment for 3 years. He was awarded a Navy commendation medal.

Some of his other accomplishments include Manpower Consultant to Commandant, United States Marine Corps, 1972-1983 and Senior Consultant, President's Commission on Military Compensation, 1977 to 1978. And, Member, Board of Directors, Children's Hospital-Northern California from 1994 to 2006.

As a Human Resources Consultant, Oakland, CA from October 1981-1997, he developed training programs and executive seminars in Labor Relations, Personnel and Equal Opportunity Affairs and provided executive search services for industry, government and educational organizations. He formed and served as Executive Director of a city-chartered organization which developed initial programs to promote minority employment, housing, educational and social opportunities to improve interracial relations.

Currently, Jackson is the Special Consultant to the President of the California Maritime Academy, 1997 to Present. And serves as the Chairman, Board of Directors of the National Minority Military Museum Foundation from 1980 to Present.

Morris Nolton Turner: Trail Blazer Cartoonist

Morris Nolton Turner who preferred to be called "Morrie" was born in Oakland, California on December 11, 1923. He attended Cole Elementary School and McClymonds High School in Oakland. Turner went on to finish his senior year and to graduate from Berkeley High School in Berkeley, California.

Turner received his first training in cartooning through a correspondence course. During World War II, he served as a mechanic with the Tuskegee Airmen. His cartoons appeared in the military newspaper *Stars and Stripes*. He was the first African American cartoonist to work with *Stars and Stripes*. After the war, Turner worked for the Oakland Police Department where he created the comic strip *Baker's Helper*.



Turner began to question why there were no minorities in cartoons. This led him to his mentor, Charles Schultz who created *Peanuts*. Schultz's answer was to the point, "create one."

His first attempt was *Dinky Fellas* which featured an all Black cast. The *Chicago Defender* was the only newspaper to carry it. Then, in 1965, Turner renamed *Dinky Fellas* to *Wee Pals* and it became the first comic strip syndicated in the United States with a cast of ethnically diverse characters. Originally, only 5 newspapers picked it up until the April 1968 assassination of Dr. Martin Luther King, Jr. when more than 100 newspapers began to carry the cartoon strip.

In 1970, Turner's popularity led him to become a co-chairman of the White House Conference on Children and Youth. He appeared on *Mr. Roger's Neighborhood* twice and talked about how each of his characters were named. His animated television series, *Kid Power*, aired Saturday mornings on ABC. During the 1972-1973 television season, *Wee Pals on the Go* was aired by another ABC facility in San Francisco. In 2003, the National Cartoonist Society recognized his work with the Milton Caniff Lifetime Achievement Award. He was awarded numerous awards and community distinctions such as the Inter-Group Relations Award from the Anti-Defamation League of Bnai Brith and the Cartoon Art Museum's Sparky Award named in honor of Charles Schultz.

The intent of his cartoons was to teach children history. He collaborated with students in the OASES Comic Book Preachers Class of drawing at Westlake Middle School in Oakland to create the book called *Wee The Kids from Oakland*. Morris (Morrie) Nolton Turner died January 25, 2014 in Sacramento, California at 90 years old.

As I mentioned on the phone, my agency is collaborating with the Alameda County Veteran Affairs Commission and a few local organizations to host a resource fair (we will call the event Stand-Down) for unhoused veterans in Oakland and broader in Alameda County. 6. Can we use your parking lot? If so, is there an additional charge for that?
7. If we partner with the Veteran Services office at Laney College and they become co-sponsors of the event, do we still need to pay the rental fees?


